## Mock Drill on Earthquake & Fire conducted by Directorate of Disaster Management

Sri Vijaya Puram, Mar. 31  
As per the directives of the Chief Secretary, Andaman & Nicobar Administration, all Departments are required to test their disaster preparedness through quarterly mock drills. In accordance with this directive, the Directorate of Disaster Management (DDM), A&N Administration conducted a Mock Drill on Earthquake and Fire at Aapda Prabandhan Bhawan, Link Road, Goalghar, Sri Vijaya Puram on March 25. The exercise involved the participation of Department staff and various Control Rooms including ERSS (112), SVP,MC, Electricity, and Transport.



Prior to the drill, a Table Top Exercise was conducted. During this session, Smti Priyanka Kumari, Director (DM), A&N Administration, emphasized the significance of the drill in evaluating preparedness and response mechanisms. She highlighted the importance of participation and coordination in such drills to enhance the Department's capacity in handling emergency situations effectively.

The drill commenced with a whistle sound simulating an earthquake scenario. Officials and staff followed the 'Duck, Cover & Hold' protocol for a few seconds before safely evacuating the building to a designated safe location. A headcount was conducted, revealing that six personnel were missing. The Incident Commander (IC), Shri Janik Ram, Assistant Director (Admn.), DDM immediately directed the communication team to seek support from the District Administration, Police, Fire Department, Health Services, NDRF, and Electricity Department for rescue operations.

Search and Rescue Teams were deployed to locate the missing personnel. The teams successfully rescued the injured individuals and informed the IC about the remaining missing persons and a fire outbreak within the building. The fire response team promptly extinguished the fire. Upon arrival, Resource Departments reported to the IC, who provided details

of the missing personnel to the Police, Fire Department, and NDRF. The remaining four missing persons were rescued, with critically injured individuals transported to the hospital via ambulance, while others received first aid on-site.

After receiving reports that the situation was under control, the IC issued an 'All Clear' message, signalling the conclusion of the drill. A debriefing session was held, where Observers from the District Administration, Police, Fire Department, Health Services, NDRF, and Electricity Department appreciated the staff and officials for their active participation and also shared their findings and identified gaps. The Incident Commander assured that all findings and gaps would be reviewed and addressed to further strengthen disaster preparedness measures, a press release from Directorate of Disaster Management said.

often exceeds 2 km, making the current population-based eligibility criterion ineffective. At present, only one habitation in the entire UT qualifies under the 250+ population criterion, leaving a major portion of the rural population without road connectivity. Many of these habitations were settled by the Government in 1965, yet, after nearly six decades, they remain without proper roads. The Island terrain, dense forests, and eco-sensitive zones further restrict large-scale infrastructure development, necessitating a lower population threshold for eligibility.

He also further emphasized that due to limited capital expenditure grants allocated to the UT Administration by the Government of India, the Administration is unable to bear the cost of rural road construction. Panchayati Raj Institutions in A&N Islands have managed to construct only 36 km of rural roads in the last five years due to financial constraints.

Keeping in view the above said justification, the Member of Parliament requested the Minister to consider for Special Relaxation in Population Criteria to allow habitations with a population of 100+ (instead of 250+) to be included under PMGSY and special sanction of 500 km of rural roads beyond its limit prescribed under PMGSY-IV to ensure the construction of pending rural roads in A&N Islands, so that the UT Administration will prepare and submit DPR accordingly, a press release from MP Office said.

the Rugose spiralling whitefly infested farmers' fields.

Smti Shiuli Mondal, Pradhan of Ramakrishnapur, PRIs followed by Smti. Sangeeta Biswas, Pradhan of Rabindra Nagar, Assistant Director (Agriculture), Agriculture Officer, Agriculture Field Assistants, ATMA staff and fellow farmers took an active role in spraying operation in the infested fields. The observed levels of infestation of Rugose Spiraling Whitefly (RSW) in these fields remains below the Economic Threshold Level (ETL), indicating that immediate action is manageable.

In addition to the pest control spraying, farmers have been sensitized on various control measures to be adopted for pest and disease infestation in their field.

Advisory notices have been circulated to PRIs and farmers to support effective pest management.
