Labour Department urges Platform and Gig workers to register on e-Shram portal

'Special Registration Camps' being held in Isles

Sri Vijaya Puram, Apr. 12

The Ministry of Labour & Employment, GoI, New Delhi, is conducting a nationwide Campaign from April 7 to 17, 2025 to organize 'Special Registration Camps' for the registration of Platform and Gig Workers. The term 'Platform Worker' refers to an individual engaged in a work arrangement outside of the traditional employer-employee relationship, wherein organizations or individuals use an online platform to access other organizations or individuals to solve specific problems or provide specific services, or any other activity as notified by the Central Government, in exchange for payment. Similarly, a 'Gig Worker' is a person who performs work or participates in a work arrangement and earns from such activities, also outside of the traditional employer-employee framework.

This initiative aligns with the Union Budget 2025-26, which announced the registration of Platform & Gig Workers on the e-Shram portal, issuance of identity cards, and the extension of health benefits under Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY).

As part of the campaign, the Labour Department, A & N Administration, has urged all Platform and Gig Workers in A&N Islands to register themselves on the e-Shram portal via the link: <https://register.eshram.gov.in/#/user/platform-worker-registration>. The workers who are unable to register themselves online may visit the Labour Department, Sri Vijaya Puram, on any working day for assistance with registration. Entries to be submitted on MyGov Andaman portal by April 15



The One Stop Centres are functioning in one roof to facilitate immediate, emergency, non-emergency services access to a range of services including Medical, Legal, minimum 5 days temporary shelter, Police assistance, Psychological and counselling support to fight any forms of violence against women.

Presently, 3 One Stop Centres are functioning in Junglighat near AYUSH Hospital for South Andaman, North & Middle Andaman in Zonal Library building at Mayabunder and in Nicobar at Perka Head Quarter. For OSC North & Middle Andaman one can contact 03192-273009 and for OSC Nicobar 03193-265141/ by self-visiting/through A n g a n w a d i Workers/ relative, friends and public servant. Traffic arrangements notified in view of Andaman and Nicobar Command Half Marathon today

In exercise of the powers conferred under the M.V. Act 1988 (Act No.59 of 1988) read with Administration's Notification No./2008/F.No.32-95/2008-TR dated 10th March, 2008, the District Magistrate, South Andaman District has notified for the information of all concerned that the following traffic arrangements have been proposed in connection with the Andaman and Nicobar Command Half Marathon on 13/04/2025 from 0400 hrs to 1000 hrs.

The vehicles intending to proceed to South Point from Aberdeen Bazaar shall be diverted towards Model School Junction and Crossing-APWD Junction-Gandhi Park - Murugan Temple-Siddique Junction-Shadipur Junction and Vice Versa.

- > No vehicle shall be allowed to ply on the route from Mazar Pahad to Police Radio, Marine Hill via Shiv Mandir, Government Press, JNRM, Girls School, Scouts House Junction, Dharamshala Junction, Tsunami Memorial (via ONE WAY), Khan Junction and Dugnabad Fish Market.
- > The vehicles intending to proceed to Aberdeen Bazaar from South Point shall follow the route of South Point-Shadipur-Nayagaon Junction-Police Line-RBV-Secretariat Junction and Goyalgar.

- > Vehicles intending to proceed towards Dugnabad Fish Market from Police Radio, Marine Hill shall opt the route from Sisty Nagar.

70th Fire Service Day to be observed on April 14

Various activities to be organized as part of Fire Service Week

The Andaman & Nicobar Fire & Emergency Services, in line with its rich tradition of service and sacrifice, will be observing Fire Service Week from 14th to 20th April, 2025, along with the rest of the nation. The observance will commence with the 70th Fire Service Day on 14th April, to pay homage in memory of the brave firefighters, who lost their lives in the line of duty and to promote awareness about fire safety among the public. This annual observance is held across the nation to commemorate the tragic incident at the Bombay Dock Explosion on 14th April, 1944, where numerous fire personnel made the supreme sacrifice while combating fire and explosions caused by the blast.

As part of the week-long observance, a series of meaningful activities have been scheduled to engage both the community and fire service personnel. A yoga session for Police personnel, a drawing competition for school children and a blood donation campaign will be held at the F&ES Headquarters. A badminton competition for Police personnel will be conducted at Netaji Stadium. Centre launches 'Global Tariff and Trade Helpdesk' to assist stakeholders in navigating trade issues

New Delhi, Apr. 12

The Centre has operationalised a dedicated 'Global Tariff and Trade Helpdesk' to assist stakeholders in navigating emerging trade issues.



The Commerce and Industry Ministry in a statement said that the Helpdesk will look into issues relating to Import and Export Challenges, Import Surges or Dumping, Logistics or Supply Chain Challenges, Financial or Banking issues and Regulatory or Compliance Issues among others.

The Help desk will also collect and collate trade-related issues concerning

other Ministries, Departments and Agencies of Central Government and State Governments. It will also coordinate to seek their support and provide possible resolutions. The Ministry added that Export-Import community may submit information on the DGFT website and information relating to their issues. Provided that in case a Union Territory does not have a Legislative Assembly, the Government concerned shall have the discretion to nominate two members from any of the other categories mentioned above.
