Readers, Students and Families flock to explore literary delights

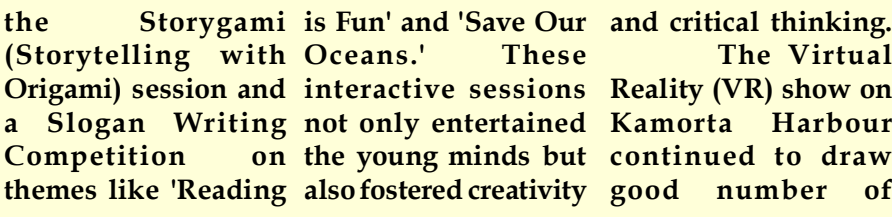


The fairground also offered a lively cultural experience with food stalls serving a variety of cuisines, making it a perfect outing for families and book enthusiasts alike.

Foreign National arrested for unauthorized visit to North Sentinel Island

Sri Vijaya Puram, Apr. 2

On the receipt of complaint of Tribal Welfare officer, a case has been registered vide PS Crime & Economic Offence FIR No. 10/25 dated 31/03/2025 U/s 14/14(A) of the Foreigners Act 1946 r.w. para 3 of the FRA Order 1963 and 7/8 of the PAT Amendment Regulation 2012. Accordingly, an arrest has been made of US National for Unauthorized Visit to North Sentinel Island, A& N Islands.

Investigation revealed that the accused, Mykhailo Viktorovych Polyakov S/o Victor Polyakov (24) yrs R/o 4848 North Goldwater, Scottsdale, Arizona 85251, USA, had intentionally visited the restricted North Sentinel Island in an attempt to interact with the Sentinelese tribe. His actions posed a serious threat to the safety and well-being of the Sentinelese people, whose contact with outsiders is strictly

prohibited by law to protect their indigenous way of life.

Moreover, Mykhailo disclosed that he was drawn to the island due to his passion for adventure and his desire to undertake extreme challenges. He was particularly fascinated by the mystique of the Sentinelese people. Intimation of the arrest was conveyed to the Ministry of External Affairs and US Embassy, a press release from SSP (CID) said.

During Peak Demand Time:

1. Avoid use of AC for 03 hours. Set your air conditioners at 25°C and save energy.
2. Avoid use of Geyser for 02 hours.
3. Avoid use of Iron box.
4. Avoid use of Induction Stove.
5. Avoid use of Washing Machine for 03 hours.
6. Avoid use of Refrigerator for 03 hours.
7. Fix float valves in water tanks to reduce consumption of electricity and wastage of water.
8. Use LED Lamps, Tube lights instead of conventional lamps and CFL tube lights.
9. Replace conventional fans with BLDC Fans.
10. Switch off lights, fans, Air Conditioners on leaving the room.
11. Avoid decorative and unnecessary lighting during peak summer; Use lighting for need.

For implementation of Digital Agriculture (Agristack) in a fast track mode in A & N Islands, Department of Agriculture, A&N Administration in association with Central Project Monitoring Unit (CPMU), Digital Agriculture Mission, Ministry of Agriculture & Farmers Welfare, Govt. of India is organizing 3 days training program on Digital Crop Survey for Master Trainers for Implementation of Digital Agriculture (Agristack) in Andaman & Nicobar Islands from 2nd to 4th April, 2025 in the Conference Hall of Directorate of Agriculture, Sri Vijaya Puram.

Speaking on the inaugural session the chief guest, Dr. Apurva Sharma, Director of Agriculture highlighted the significance of the Digital Agriculture Mission, a Government of India initiative aimed at empowering farmers.

Earlier, Shri Ramesh Kumar, Joint Director (Agri), extended a warm welcome to the chief guest, resource persons from Ministry, and the trainees. He emphasized that, as a new dimension in agriculture for these Islands, it is crucial for the trainees to gain a thorough understanding of Digital Agriculture to effectively implement it in the field.

Ms. Kirti Kumari, Resource Person, Central Project Monitoring Unit (CPMU) detailed about the course content of the training and insisted for effective implementation of the mission in this UT. The important contents to be covered in the training are Farmers Registry/Database, Geo Referenced Village Maps and Crop Sown Registry or Database collected through Digital Crop Survey (DCS) system.

The team of Resource Persons from Central Project Monitoring Unit (CPMU) will be imparting training on Digital Crop Survey. Four villages of South Andaman zone so far have been Geo-referenced. Hands on training on Digital Crop Survey will be conducted in the Nayashahar Village which has already been Geo-reference as a Pilot Project.

The inaugural session concluded with the vote of thanks proposed by Shri Navasakthi, Assistant Director (Agri), Extension. Altogether 16 Master Trainers from Department of Agriculture, Revenue and SOVTECH are attending the training Programme, a press release from Agri. Deptt. said.

PS Campbell Bay initiates firm action against illegal liquor

A special Excise Raid/Jungle Search was carried out on April 1 & 2 by a Police team led by SI Vinit Kumar Maurya, PS Campbell Bay. The Sirens have been installed to alert the general public during any Disaster which is blown at high pitch/volume. The Siren will be blown in the following manner during occurrence of the disaster :-

03.	EQ> 6.5 M Wave Amplitude above 2.00 Mtr.	Three Long Blast	1) People in affected areas to evacuate 2) Vessel to move into deep ocean

The siren will be tested on 3rd and 18th of every month at 1000 Hrs. during the test, the siren will be blown for two successive blast for 30 seconds. Siren of Electronic Display Board installed at Police Control Room, State Control Room, Junglighthat (Fisheries Dept.), Met Office, MRCC, JOC, INS Jarawa at Sri Vijaya Puram, Fisheries Dept. at Rangat, EOC at Mayabunder, MRCC at Diglipur, Fisheries Dept. at Hut Bay, EOC at Kamorta, EOC at Car Nicobar, and MRCC & EOC at Campbell Bay will also be blown in a similar manner at 1000 Hrs.

Therefore, the general public is hereby informed not to panic during the test of siren and requested to remain calm during test blast of siren on the date and time specified above.

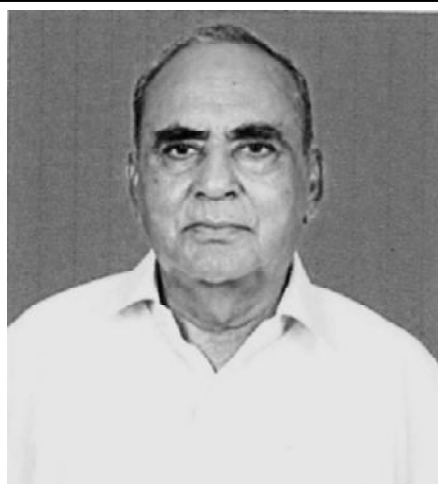
