## Govt. to conduct population Census 2027 in two phases with caste enumeration

New Delhi, June 4

The Government has decided to conduct Population Census in 2027 in two phases, along with the enumeration of castes. The reference date for the census will be first of March, 2027. In a statement, Union Home Ministry said, the reference date for Ladakh and the non-synchronous snow-bound areas of Jammu and Kashmir, Himachal Pradesh and

Uttarakhand will be first of October, 2026. The notification for the intent of conducting Population Census with these reference dates is likely to be published in the official gazette on 16<sup>th</sup> of this month. The last census was conducted in 2011 in two phases. These were Phase I - House Listing and Phase II - Population Enumeration. The census 2021 was also proposed to be conducted

in two phases in a similar manner with phase I during April-September 2020 and second phase in February 2021. All the preparations for the first phase of the Census to be conducted in 2021 were completed. However, the census work was postponed due to the outbreak of COVID-19 pandemic across the country. ## Massive jungle raid conducted in Perka to crack down on illicit liquor production

Car Nicobar, June 4

A significant operation was carried out in the dense forest areas of Perka (Headquarters), Car Nicobar recently, under the direct supervision of the Superintendent of Police, Nicobar District. Acting on credible intelligence inputs, the Police team of Station House Officer of P5 Car Nicobar launched a well-planned jungle raid aimed at dismantling unauthorized distillation activities. During the operation, Officers located and destroyed

approximately 4,500 litres of lahen (fermented wash used in the distillation of illicit liquor). The fermented liquid was stored in several plastic containers and carefully concealed within dense undergrowth to evade detection.

In addition to the destruction of the illicit wash, the team recovered and seized multiple distillation apparatus and related materials from the site.

This raid is part of an ongoing crackdown to

eliminate illegal liquor production in the Nicobar Islands. 11890 litres of lehan has been destroyed and 259.8 litres of illicit liquor has been seized in the current year.

The entire search operations were conducted under the supervision of Shri Aditya Kumar, SDPO, Campbell Bay and under overall supervision and direction of SP (D) Nicobar, Shri Rahul L Nair, IPS, a press release from SP (Nicobars) said.

of the drill. The fire tender reached and doused the fire at the incident site and also the fire team rescued the missing persons and handed over to the first aid team of the Department, who were taken by ambulance to be hospitalized for further treatment. The drill concluded with the issuance of the 'All Clear' message by the Incident Commander.

During the debriefing session, the Assistant Director, DM, Shri Janik Ram emphasized the importance of regularly conducting such exercises to strengthen the disaster preparedness of the Departments. Officials from the resource Departments also shared their observations and appreciated the staff's adherence to the mock drill procedures and also recommended updating resources to effectively handle emergencies, a press release from Directorate of Disaster Management said.


